Louisiana Rumble will try to accommodate Vendor site requests as much as possible.

Vendor shall obtain any necessary licensing and/or insurance as required by Louisiana law and is encouraged to apply for a Louisiana revenue account for sales tax submission prior to the event at: <https://latap.revenue.louisiana.gov/>.

All Vendor items, except displays in front of Vendor booth space, shall fit within Vendor's designated booth space. Vendor shall sell only those items listed in Vendor application.

Vendors shall not use the Louisiana Rumble name or logo on any merchandise nor sell, give, or offer for sale any photographs or videos taken during this event without express permission of Louisiana Rumble management.

Vendor will not hold Louisiana Rumble and/or its partners, sponsors, promoters, beneficiaries, staff, volunteers responsible for any injury, illness, damages, loss or theft during the event. Vendor assumes any and all risk that may arise relating to attendance at the event. Louisiana Rumble is a rain or shine event; No refunds due to weather.
